## REQUIRED FEES

There is no additional charge for renewal if you submit your Twic Application on time, but late renewals may incur extra costs.

## STEP 4: WAIT FOR THE BACKGROUND CHECK AND CARD ISSUANCE

Once your documents and biometrics are submitted, the TSA begins the security threat assessment. This process involves checking your name against terrorist watchlists, criminal databases, and immigration records. The background check for a Twic Application typically takes four to six weeks, but it can take longer if there are complications or high volumes of applications. You can check your application

status online using your confirmation number. If approved, your TWIC card will be mailed to the address you provided during pre-enrollment. It is highly recommended to renew early to avoid a lapse in credentials. Note that you cannot simply receive a new card by mail; the biometric verification must be redone periodically to ensure security.
