## The Digestive System

From mouth to anus, the digestive system breaks down food into absorbable nutrients. Its anatomical components include the esophagus, stomach, small intestine, large intestine, liver, pancreas, and gallbladder. Physiologically, digestion involves mechanical processes (chewing, peristalsis) and chemical processes (enzymatic breakdown). The unique lining of the small intestine, with its finger-like villi, increases surface area for nutrient absorption—another structural

adaptation for a physiological need.

## The Endocrine System

The endocrine system comprises glands that secrete hormones—chemical messengers that regulate metabolism, growth, reproduction, and mood. Major glands include the pituitary, thyroid, adrenal, pancreas, and gonads. Anatomically, each gland has a distinct location and cellular structure. Physiologically, hormones travel through the bloodstream to target cells, where they trigger specific responses. For instance, insulin from the pancreas lowers blood glucose levels, illustrating how a small anatomical structure can

exert whole-body effects.
