## 1. The Interquartile Range (IQR) Method

The IQR method is one of the most popular and robust ways to determine outliers, especially for skewed distributions. It uses quartiles to create a “fence” beyond which data points are considered potential outliers.

1. **Calculate the first quartile (Q1)** — the median of the lower half of the data.
2. **Calculate the third quartile (Q3)** — the median of the upper half.
3. **Find the interquartile range:**  $IQR = Q3 - Q1$ .
4. **Define the lower fence:**  $Q1 - 1.5 \times IQR$ .
5. **Define the upper fence:**  $Q3 + 1.5 \times IQR$ .

Any data point below the lower fence or above the upper fence is considered an outlier. This method is favored because it is not heavily influenced by extreme values themselves — the IQR itself resists skewing.

## 2. Standard Deviation / Z-Score Method

When data is approximately normally distributed, we can use the standard deviation to identify outliers. A common rule is to treat any data point with a **z-score** greater than 3 (or less than -3) as an outlier. The z-score tells you how many standard deviations a point is from the mean.

Formula:  $z = (x - \mu) / \sigma$ , where  $\mu$  is the mean and  $\sigma$  is the standard deviation.

While simple, this method is sensitive to the presence of outliers themselves because mean and standard deviation can be pulled by extreme values — a phenomenon called “masking.”

## TYPES OF OUTLIERS: UNIVARIATE

### 3. Box Plot Visual Detection

A box plot (or box-and-whisker plot) provides a visual representation of the IQR method. The “whiskers” extend to the smallest and largest data points within the fences, and any points beyond the whiskers are plotted individually — those are your outliers. Box plots are excellent for quick visual inspection, especially when comparing multiple groups.

### 4. Modified Z-Score (MAD-based)

To overcome the masking problem of standard z-scores, many analysts use the median absolute deviation (MAD). A modified z-score replaces the mean with the median and the standard deviation with MAD. A common threshold is a modified z-score greater than 3.5.

### 5. Grubbs' Test and Other Formal Tests

For datasets where a single outlier is suspected, statistical hypothesis tests like Grubbs' test can be used. However, these tests assume normality and are not suitable for multiple outliers without modification.

## AND MULTIVARIATE

The meaning of outlier in math can also be classified by the number of variables considered:

- **Univariate outliers:** Occur when a single variable has an extreme value. Example: Age = 200 in a dataset of human ages.
- **Multivariate outliers:** Occur when a combination of two or more variables is unusual, even if each individual variable falls within a normal range. Example: A person with a height of 5'6" and a weight of 350 lbs — the height is normal but the combination is extreme.

Multivariate outliers are often more subtle and require techniques like Mahalanobis distance or scatter plots to detect.

In regression analysis, an outlier may not always be influential — meaning it does not dramatically change the slope of the regression line. Conversely, a point may be influential without being an extreme outlier if it has high leverage (e.g., an extreme x-value that pulls the line).
