## UNDERSTANDING YOUR REGIONS BANK STATEMENT: A COMPLETE GUIDE

It provides a clear snapshot of your account activity, helping you track spending, monitor deposits, and ensure your account is secure. ### WHAT IS A REGIONS BANK STATEMENT?

A **Regions Bank Statement** is a periodic summary provided by Regions Bank for checking, savings, money market, and other accounts. It lists all transactions that occurred during a specific statement cycle — typically one month. The statement includes deposits, withdrawals, checks cleared, electronic transfers, fees, and interest earned (if applicable). Crucially, it also shows your beginning and ending balances, allowing you to verify that your own records match the bank's.

These statements serve several purposes: they help you budget, provide proof of transactions for tax or legal purposes, and act as an early warning system for fraudulent activity. Whether you receive your statement by mail or electronically, the content is essentially the same, though the delivery method affects how quickly you can review it.

### HOW TO ACCESS YOUR REGIONS BANK STATEMENT

Regions offers multiple ways to view your statement, giving you flexibility based on your preferences. Here are the three main methods:

- 1. Online Banking (Desktop or Mobile App)**  
Log in to your Regions Online Banking account. Under the account summary, look for a tab or link labeled "Statements & Documents." Typically, you can view up to 7 years of statements in PDF format. The online portal also allows you to download, print, or e-mail a copy of your statement.
- 2. E-Statement Enrollment**  
If you want to receive emails with a link to your statement each month rather than a paper copy, opt into e-statements. Enrolling is simple through your online banking dashboard. Not only does this reduce clutter and paper waste, but you also get access to your statement days earlier than the mailed version.
- 3. Mailed Paper Statement**  
By default, new checking accounts typically receive a paper statement for the first few months. After that, you may be automatically enrolled in e-statements unless you opt out. However, some customers prefer paper for record-keeping. You can request paper statements at any time — note that

there may be a small fee associated with monthly paper statements on certain accounts.

If you have a joint account, each account holder can access the same statements through their own online banking credentials.

## KEY COMPONENTS OF A REGIONS BANK STATEMENT

Understanding exactly what each section means prevents confusion and helps you spot errors. Below is a breakdown of the typical elements found on a **Regions Bank Statement**.

### Account Summary

This section appears near the top of the statement and provides a quick overview. It includes the statement period, beginning balance, total deposits/credits, total withdrawals/debits, any service charges, and the ending balance. For interest-bearing accounts, the annual percentage yield (APY) and interest earned are also summarized here.

### Transaction Details

The heart of the statement is the detailed transaction list. Each line item typically shows the date, description, check number (if applicable), and amount. Transactions are usually grouped by type — for example, deposits first, then withdrawals, then checks, then ATM transactions. For electronic transactions, you'll see merchant names or bill pay descriptions.

### Check Images

If you wrote checks during the statement period, the statement may include images of the front and back of each cleared check. In online statements, these are often available as a downloadable set or viewable as thumbnails. This feature is especially useful if you need to prove payment or resolve a dispute.

### Fees and Charges

Any monthly maintenance fees, overdraft fees, or other charges appear in a separate section or are itemized within the transaction list. If you see a fee you don't recognize, it's important to contact Regions promptly. Many fees, such as a monthly paper statement fee, can be avoided by switching to e-statements.

### Important Messages

Regions often includes regulatory disclosures, promotional offers, or updates to terms and conditions in a small section at the bottom or on the back of the statement. These may require your attention, such as changes to overdraft policies or new security features.

## HOW TO READ CODES AND ABBREVIATIONS ON YOUR REGIONS STATEMENT

Transaction descriptions sometimes include shorthand codes. Here are common ones you may see on your **Regions Bank Statement**:

- **ATM / POS** — ATM withdrawal or debit card point-of-sale transaction.
- **ACH** — Automated Clearing House electronic transfer (e.g., direct deposit or a bill payment).
- **WD** — Withdrawal.
- **DEP** — Deposit.
- **INT** — Interest payment.
- **SRV CHG** — Service charge or fee.
- **CK** followed by a number — Check number that cleared.
- **DEBIT CARD PURCHASE** — A transaction made with your Regions debit card, sometimes showing the merchant’s name truncated.

If you see an acronym or code that doesn’t make sense, consult the glossary within online banking or call Regions customer service. Misreading a code could lead to unnecessary worry about an unfamiliar charge.

# Reconcile Your Accounts Monthly

Compare your statement to your own check register, budgeting app, or spreadsheet. This process, called reconciliation, ensures that every transaction is accounted for and that no errors or fraudulent charges slipped through. If you find a discrepancy, note it and contact Regions within 60 days (the typical window for disputing errors on statements).

# Track Spending Patterns

Use the transaction list to identify where your money goes. Categorize expenses — groceries, utilities, entertainment — and see if you can cut back. Many Regions customers also use the budgeting tools inside the mobile app to link their statement data for even clearer insights.

# Spot Unauthorized Activity Early

Because statements are delivered periodically (usually every 30 days), you might not notice a small charge right away. However, reviewing each line item carefully can reveal subscription payments you forgot about or potential identity theft. If you see a charge you don’t recognize, report it immediately.

**PAPERLESS STATEMENTS VS. PAPER STATEMENTS: PROS AND CONS**

Regions encourages e-statements by offering easy enrollment and sometimes waiving certain fees. But which option is right for you? Compare the two:

For most people, e-statements offer a good balance of convenience, cost savings, and environmental benefits. However, if you are not comfortable with digital access or need physical copies for record-keeping, paper statements remain available.

**SECURITY TIPS FOR HANDLING YOUR REGIONS BANK STATEMENT**

Your bank statement contains sensitive information: your name, address, account number, and transaction history. Protecting it is essential. Follow these practices:

- **Shred old paper statements** before discarding them. A cross-cut shredder prevents dumpster divers from reclaiming your details.
- **Use strong, unique passwords** for your Regions online banking account. Enable two-factor authentication for an extra layer of security.
- **Avoid viewing statements on public Wi-Fi** or shared computers. If you must, use a VPN or wait until you are on a secure network.
- **Download and store statements in a password-protected folder** on your computer or a cloud service with encryption. Do not leave them in your email inbox indefinitely.
- **Monitor your account throughout the month**, not just when the statement arrives. Regions’ mobile app lets you set alerts for large transactions or low balances.

# I Didn’t Receive My Statement

First, check your spam folder if you are enrolled in e-statements. Then log into online banking and navigate to “Statements & Documents” — even if you missed the email, the PDF is typically available. If you still cannot see it, check that your email address or mailing address is current in your profile. You may also call Regions to request a reprint (a fee may apply for paper reprints).
