In each of these scenarios, the court will require a completed worksheet as part of the initial filings or as supporting documentation during a hearing. Even if both parents agree on a support amount, the court typically reviews the worksheet to ensure the agreed amount is consistent with state guidelines.

## **UNDERSTANDING THE LEGAL FRAMEWORK BEHIND THE WORKSHEET**

## Parental Income Information

These adjustments help arrive at each parent's **adjusted gross income**, which

is the figure used in the final calculation.

## Number of Children and Combined Income

The worksheet considers the total number of children covered by the support order. Parents must also list other children they are legally obligated to support, as this affects the calculation. The combined adjusted gross income of both parents is then used to find the **basic child support obligation** from a schedule included in

the statute.

## Extraordinary Expenses

Beyond basic support, the worksheet accounts for additional costs that are essential for the child's well-being. These include:

- Childcare expenses necessary for work or education
- Health insurance premiums for the child
- Uninsured medical, dental, and vision expenses
- Educational expenses, such as private school tuition in some cases

These costs are typically added to the basic obligation and shared between parents in proportion to their incomes.

## Parenting Time Adjustment

Colorado law allows for a parenting time adjustment when the non-custodial parent exercises at least 93 overnights per year (roughly 25% of the time). The worksheet calculates a credit for the expenses the non-custodial parent incurs directly during parenting time, such as food, housing, and activities. This adjustment can significantly reduce the final support amount but is not automatic for very low parenting time schedules.

### HOW TO FILL OUT THE COLORADO CHILD SUPPORT WORKSHEET STEP BY STEP

Filling out the form correctly is essential to avoid delays or inaccurate orders. Here is a practical step-by-step guide.

#### **Step 1: Gather Financial Documents.**

**Step 4: Apply Allowed Deductions.** Subtract any allowable items such as spousal maintenance paid or health insurance premiums already being paid for the child. These deductions reduce your adjusted income and can lower your obligation.

**Step 5: Determine the Basic Child Support Obligation.** Using the combined adjusted income and the number of children, find the corresponding amount in the child

support schedule. This schedule is included in the guidelines and is updated periodically.

**Step 6: Add Extraordinary Expenses.** Include childcare, health insurance, and uninsured medical costs. The total is added to the basic obligation.

**Step 7: Calculate Each Parent's Share.** Each parent's proportional share of income determines their portion of the total obligation. For example, if Parent A earns 60% of the combined income, they are responsible for 60% of the total support.

**Step 8: Apply the Parenting Time Adjustment (if applicable).** If the non-custodial parent has 93 or more overnights per year, calculate the credit using the worksheet's formula. This



reduces the amount owed to account for direct expenses.

**Step 9: Determine the Final Support Amount.** The result is the presumptive monthly child support order. This is the amount one parent pays to the other unless the court approves a deviation.

### **ADJUSTMENTS AND DEVIATIONS FROM THE WORKSHEET AMOUNT**

While the worksheet provides a presumptive amount, Colorado law recognizes that no formula can account for every family's unique situation. A court may deviate from the worksheet amount if applying it would be **unjust or inappropriate**. Grounds for deviation include:

- Extraordinary medical expenses

not covered by insurance

- Special educational needs or disabilities
- Significant disparity in the parents' incomes
- Voluntary unemployment or underemployment intended to avoid support
- Agreement between both parents (if the court approves)

If you believe a deviation is necessary, you must present evidence and explain why the standard calculation is unfair. The court will consider the child's best interests above all else.

### **COMMON MISTAKES WHEN COMPLETING THE WORKSHEET**

Avoiding errors can save time, money,

and stress. Here are the most common mistakes parents make when filling out the **State of Colorado Child Support Worksheet**:
