- **Major and minor grooves:**

The winding of the helix creates grooves that serve as binding sites for proteins that regulate gene expression and replication.

The stability of the DNA double helix is enhanced by base-stacking interactions and hydrogen bonding. This structural architecture directly enables its function: the sequence of bases along the DNA molecule encodes the genetic blueprint, while the complementary strands allow for accurate duplication during cell division.

RNA

Structure: More Flexible and Versatile

Unlike the rigid double helix of DNA, RNA molecules can adopt a variety of shapes. Single-stranded RNA often folds back on itself to form local double-stranded regions through complementary base pairing (A pairs with U, G pairs with C). This creates structures like stem-loops, bulges, and hairpins. The **structure and function of nucleic acid** are especially

evident in RNA, where the 3D shape is essential for function. For example, transfer RNA (tRNA) has a cloverleaf secondary structure that folds into an L-shaped tertiary structure, allowing it to carry amino acids to the ribosome. The greater chemical reactivity of the ribose sugar also allows RNA to act as both a genetic material and a catalyst in some cellular processes, a concept central to the RNA world hypothesis.

DNA Replication: Passing on the Code

DNA, and DNA polymerase reads the original strand and synthesizes a new complementary strand using free nucleotides. Because of base-pairing rules, each new DNA molecule consists of one old strand and one new strand—a process called semiconservative replication. This accuracy is critical; errors can lead to mutations, which may be harmless, beneficial, or cause diseases like cancer. Translation: Building Proteins

The final function in the flow of genetic

information is translation, where the mRNA sequence is decoded to produce a polypeptide chain (protein). This process occurs on ribosomes, which are made of rRNA and proteins. Transfer RNA (tRNA) molecules act as adaptors: each has an anticodon that base-pairs with a specific codon on the mRNA, and carries the corresponding amino acid. As the ribosome moves along the mRNA, tRNAs bring amino acids one by one, forming a growing protein chain.
