## **UNDERSTANDING THE ROLE OF THE LICKING COUNTY AUDITOR**

---

When residents of Licking County, Ohio, hear the term "county auditor," they might think of property taxes or driver's license plates. In reality, the Licking County Auditor serves as the chief fiscal officer and the tax assessor for the county. This office touches nearly every aspect of local government finance, from valuing real estate to managing tax

distributions. Whether you are a homeowner, a business owner, or simply a resident curious about how your tax dollars are allocated, the Licking County Auditor provides essential services that affect your daily life. Understanding what this office does can help you make informed decisions about your property, your taxes, and your community.

The Licking County Auditor is an elected official who serves a four-year term. The position is nonpartisan, meaning the auditor is

expected to serve all residents equally, regardless of political affiliation. The office is located in the Licking County Administration building in Newark, Ohio, and maintains a robust online presence for easy access to records and forms. The auditor's primary duties include property appraisal, tax calculation, and financial oversight of county government. Let's explore these responsibilities in detail.

## Property

# Appraisal and Valuation

One of the most visible duties of the Licking County Auditor is the appraisal of all real property within the county. This includes residential homes, commercial buildings, industrial sites, and agricultural land. Ohio law requires a full reappraisal every six years, with an update (or "triennial update") in the third year between reappraisals. The auditor's team uses market data, property inspections, and statistical models to determine fair market values. These values form the basis for property tax calculations. Accurate

appraisals ensure that the tax burden is distributed equitably among all property owners.

- **Residential Appraisals:** The auditor considers recent sales of comparable homes, square footage, age, condition, and location.
- **Commercial Appraisals:** Income potential, replacement costs, and market rent are evaluated for businesses and rental properties.
- **Agricultural Appraisals:** Special valuation methods are used for farmland, based on productivity rather than market value.

- **Personal Property:** For businesses, the auditor also assesses tangible personal property such as machinery, equipment, and inventory (though this is being phased out for many entities).

## Property Tax Administ ration

Once property values are established, the Licking County Auditor calculates the tax amounts for each parcel. This is done by applying the local tax levy rates to the

assessed value. The auditor does not set the tax rates—those are determined by voters, school boards, township trustees, and other taxing authorities through levies. However, the auditor ensures that the correct rate is applied to each property and that exemptions (such as the Homestead Exemption for seniors or the Owner-Occupancy Credit) are properly granted. The auditor also handles tax abatements for economic development projects, which are agreements that temporarily reduce taxes to encourage business investment.

## Financial

# Oversight of County Funds

The Licking County Auditor acts as the chief accountant for the county. All county departments and agencies submit their financial transactions to the auditor for recording and approval. The auditor issues checks for payroll and vendor payments, maintains the county's accounting records, and prepares the annual financial report. This role is crucial for transparency and accountability, as it ensures that public funds are used properly and in accordance with state law.

# Weights and Measures Inspection

Another service provided by the Licking County Auditor is the inspection of commercial weighing and measuring devices. Gas pumps, grocery store scales, and deli scales must be checked annually to ensure accuracy. This protects consumers from being overcharged and businesses from unfair competition. The auditor's office also investigates complaints about fuel quality and meter

errors.

# Motor Vehicle and Dog Licensing

While many people associate vehicle registration with the Bureau of Motor Vehicles (BMV), the Licking County Auditor also plays a role. The auditor serves as a deputy registrar for the BMV, meaning residents can renew vehicle registrations and obtain license plates at the auditor's office. Additionally, the auditor issues dog licenses, which are required for all dogs over three months old in Ohio. Revenue from dog licenses supports

animal control and shelter services in the county.

## Online Property Search and Tax Records

One of the most popular services is the online property search tool. Anyone can visit the Licking County Auditor's website and search for property information by address, parcel number, or owner name. The search

returns details such as the current appraised value, tax history, ownership information, and parcel maps. This is an invaluable resource for homebuyers, real estate agents, and anyone curious about a neighbor's property. You can also view the tax due dates and pay your taxes online through a secure portal.

# Programs Tax Map and GIS Information

The Licking County Auditor administers several tax relief programs for eligible residents. The Homestead Exemption reduces property taxes for qualifying seniors (age 65 and over) and permanently disabled persons. The Owner-Occupancy Credit provides a small reduction for homeowners who occupy their property. There are also special programs for veterans with disabilities and surviving spouses of veterans or first responders. The auditor's staff can help you determine your eligibility and assist with the application process.

Geographic Information Systems (GIS) are used by the auditor to create detailed tax maps. These maps show parcel boundaries, roads, waterways, and zoning information. The public can access these maps online or at the auditor's office. They are useful for land surveying, development planning, and understanding property lines. The auditor also maintains historical maps and aerial photography.

# Notary Public Services

The Licking County Auditor's office provides free notary services for county residents. If you need a document notarized, such as a deed, power of attorney, or affidavit, you can visit the auditor's office during business hours. This is a convenient way to handle legal documents without paying a private notary.

## HOW THE LICKING COUNTY AUDITOR AFFECTS YOU

---

The work of the Licking County Auditor directly impacts your wallet and your rights as a

property owner. The accuracy of property valuations affects your tax bill—if your home is overvalued, you may be paying more than your fair share. Conversely, if it is undervalued, others may be subsidizing your lower taxes. The auditor's office provides an appeal process for property owners who disagree with their valuation. Every year, thousands of Licking County residents file informal complaints or formal appeals to the Board of Revision.

Understanding the timeline and procedures can help you successfully challenge an inaccurate assessment.

For business owners, the auditor's oversight of personal property and commercial

appraisals influences operating costs. Economic development abatements can reduce tax burdens for new businesses, encouraging job creation. The auditor also verifies that commercial scales and fuel pumps are accurate, protecting both the business and the consumer.

For local governments and schools, the auditor's accurate appraisals and timely tax distributions are essential. The county auditor collects property taxes and distributes them to townships, cities, school districts, libraries, and other taxing entities. If the auditor's calculations were flawed, these entities could face budget shortfalls or surpluses, affecting

public services like police, fire, roads, and education.

## **ACCESSING THE LICKING COUNTY AUDITOR'S OFFICE**

The Licking County Auditor's office is located at 20 South Second Street, Newark, Ohio 43055. Office hours are typically Monday through Friday from 8:00 AM to 4:30 PM, excluding holidays. You can also reach them by phone at (740) 349-6140 or via email. The website provides a wealth of information, including downloadable forms, online payments, and frequently asked questions. In 2023, the office launched an upgraded property search portal with improved mapping and mobile responsiveness. The auditor also

maintains a Facebook page to announce important deadlines, such as tax due dates and reappraisal notices.

## **ELECTION AND TERM OF THE LICKING COUNTY AUDITOR**

---

The Licking County Auditor is elected by county voters in partisan elections (though the office itself is nonpartisan in function). The current auditor was elected to a four-year term that ends in 2024. Candidates must be at least 18 years old, a resident of Licking County, and a registered voter. The position requires knowledge of accounting, real estate appraisal, and public finance. Many auditors hold professional

certifications, such as Certified Public Accountant (CPA) or County Auditor Certification from the Ohio Auditor of State. The transition between administrations is overseen by the County Budget Commission to ensure continuity.

## **COMMON QUESTIONS ABOUT THE LICKING COUNTY AUDITOR**

# How often are property values updated?

Property values in Licking County are

reappraised every six years using market data. In the third year between reappraisals, a triennial update is performed to adjust values based on recent sales. This means property values are revised every three years, but full inspections occur less frequently.

## Can I file my property taxes online?

Yes, the Licking County Auditor accepts property tax payments online via its website. You can pay using a credit card, debit card, or electronic check.

There is a convenience fee for card payments but not for e-checks. You can also pay by mail or in person.

## What if I cannot afford my property taxes?

If you are struggling to pay property taxes, contact the auditor's office. There may be payment plans or deferrals available for qualifying individuals. For seniors and disabled persons, the Homestead Exemption can reduce the tax burden. The office can also direct you to local assistance programs.

Property owners can file a complaint with the Licking County Board of Revision. The deadline is typically March 31 of the year following the appraisal. You will need to provide evidence of your property's market value, such as a recent appraisal or recent sale. The auditor's staff can explain the process and provide forms.

Does the

licenses?

No, the auditor's office only handles vehicle registration and license plate renewals. Driver licenses and state IDs are issued by the Ohio BMV, which has separate offices in Newark and other locations. However, the auditor does offer many other services as described above.
