It is important to note that the Army 346 License Form is not a civilian driver’s license. Instead, it specifically authorizes the operation of military tactical vehicles (such as HMMWV’s, LMTV’s, and heavy trucks), engineering equipment (like graders, loaders, and bulldozers), and other specialized fleet assets. Without a valid DA Form 346 on record, a soldier is not legally permitted to drive any Army-owned vehicle — even if they hold a valid state driver’s license.

Who Needs the Army 346 License Form?

Any soldier whose duties require operating Army vehicles or equipment must possess a current, properly filed Army 346 License Form. This includes:

- **Combat Arms personnel** (infantry, armor, artillery) who drive tactical vehicles during field exercises.
- **Motor transport operators** (88M Military Occupational Specialty) whose primary job is driving heavy trucks and convoys.
- **Engineer equipment operators** (12N, 12T) who run graders, scrapers, and excavators.
- **Maintenance and support soldiers** who need to move vehicles around motor pools or work sites.
- **Officers and NCOs** who supervise vehicle operations and may need to drive during inspections.

Even if you only occasionally drive an Army vehicle during annual training or a deployment, you must have a completed and approved DA Form 346 on file with your unit’s licensing section. Additionally, each vehicle category requires its own endorsement on the form. For example, driving a light tactical vehicle (like a HMMWV) is one category, while operating a heavy wrecker requires a separate qualification.

Why the Army 346 License Form Matters

The importance of the Army 346 License Form cannot be overstated. First and foremost, it is a **safety requirement**. Military vehicles are often larger, heavier, and far more powerful than civilian automobiles. They operate in hazardous environments, including rough terrain, combat zones, and congested training areas. A well-maintained licensing program ensures that the right soldiers are trained and certified to operate the equipment their mission requires. Without this system, commanders would not know who is qualified to drive which vehicle — a dangerous uncertainty in any operation.

Step-by-Step Guide to Obtaining an Army 346 License

The process of getting your Army 346 License Form completed can seem intimidating, but breaking it down into clear steps makes it manageable. Follow this guide to ensure you meet all requirements.

STEP 1: DETERMINE WHICH VEHICLES OR EQUIPMENT YOU NEED TO OPERATE

Before you do anything else, identify the specific vehicles or equipment your duties require. Each type has a unique license code. Common codes include:

- **Code A (Light Wheeled Vehicle)** — sedans, pickup trucks, SUVs, up to 1-ton capacity.
- **Code B (Medium Wheeled Vehicle)** — 2.5-ton and 5-ton cargo trucks like the LMTV and FMTV.
- **Code C (Heavy Wheeled Vehicle)** — heavy equipment transporters, tank retrievers, and tractor-trailer combinations.
- **Code E (Engineering Equipment)** — bulldozers, graders, backhoes, scrapers.
- **Code F (Forklift)** — material handling equipment.

Your supervisor or unit licensing NCO can help you identify the exact codes you need.

STEP 2: COMPLETE REQUIRED TRAINING

The Army mandates that all operators undergo training before testing. This typically includes:

- **Classroom instruction** on vehicle safety, preventive maintenance, and Army driving regulations.
- **Hands-on training** under the supervision of a qualified instructor or senior operator.
- **Completion of any prerequisite online courses** (e.g., the Army Training and Certification system or the Driver’s Training Course).

Training hours vary by vehicle complexity. For a simple light wheeled vehicle, a few hours may suffice. For heavy equipment, you might need several days of practice.

STEP 3: PASS THE WRITTEN AND PRACTICAL EXAMINATIONS

Once training is complete, you must pass a **written test** covering vehicle specifications, safety regulations, and emergency procedures. The test is usually administered by a unit Test Control Officer (TCO). After passing the written portion, you will take a **practical driving test** in the actual vehicle. The evaluator will check your ability to perform a pre-operation inspection (PMCS), drive safely in traffic or off-road, park, and maneuver in confined spaces. You must achieve a score of at least 80% to pass each component.

STEP 4: COMPLETE THE ARMY 346 LICENSE FORM

After passing both exams, the Test Control Officer (or your unit’s licensing clerk) will fill out **DA Form 346**. The form will include:

- Your full name, rank, and SSN (or DOD ID number).
- The vehicle code(s) you are licensed for.
- The date of the test and the expiration date (typically 4 years for most licenses).
- Signatures from the TCO and your commander or their designee.

Make sure all information is accurate before signing. Errors could delay processing or cause the form to be rejected during an audit.

STEP 5: SUBMIT THE FORM AND OBTAIN YOUR LICENSE CARD

The completed DA Form 346 is typically filed in your unit’s master licensing file. Some units also issue a **pocket-sized license card** (SF 46 or a locally generated card) that you can carry while on duty. Keep this card with you whenever you operate government vehicles. The form itself remains in your unit’s records.

Remember that your license is not permanent. It must be renewed before the expiration date. Renewal usually requires a refresher course and a new practical test, though some units allow an abbreviated process for good drivers.

Common Mistakes to Avoid When Handling DA Form 346

Even experienced soldiers can make errors with the Army 346 License Form. Avoiding these pitfalls will save you time and prevent administrative headaches.

- 1. **Driving without a valid form:** Never operate an Army vehicle if your DA Form 346 has expired or if you do not have it on file. Even moving a vehicle a few feet in a motor pool can result in an Article 15 if caught.
- 2. **Using the wrong vehicle code:** Your license only applies to the specific codes listed on the form. If you need to drive a different type of vehicle, you must go through the testing process again for that code.
- 3. **Allowing the form to expire:** Mark your calendar! Many soldiers forget to renew until they are stopped by a safety inspector. Set a reminder at least 60 days before the expiration date.
- 4. **Omitting signatures:** DA Form 346 requires both the TCO and commander signatures. An unsigned form is invalid. Always double-check before filing.
- 5. **Losing your license card:** While the official record is on file, losing your card can delay operations. Report a lost card immediately and request a replacement from your licensing NCO.

How the Army 346 License Form Integrates with Army Safety

Programs

The Army 346 License Form is not a standalone document; it is part of a broader safety ecosystem. It connects to the **Army Accident Avoidance Program**, the **Motor Vehicle Accident Prevention Program**, and the **Ground Risk Management** process. When a unit conducts a risk assessment for a convoy or field exercise, one of the first things they verify is that every driver has a current DA Form 346. This ensures that no untrained operator is placed behind the wheel of a vehicle that could cause injury or damage.

Furthermore, the form supports the Army’s **Digital Training Management System (DTMS)** and the **Army Training and Certification System (ATACS)**, which allow commanders to track licensing status across the unit.
