Reference services are at the heart of librarianship. The exam will assess your knowledge of the reference interview process, including techniques for clarifying patron questions and identifying the most appropriate resources. You should be familiar with major reference works, both print and electronic, as well as strategies for searching databases and evaluating sources. Practice conducting virtual reference interviews and become comfortable with the ethical considerations

involved in providing information services.

Catalogin g and Classifica tion

Cataloging questions on the exam often focus on the application of standard descriptive cataloging rules and classification systems. You should understand the principles of Resource Description and Access (RDA), the use of MARC formats, and the structure of the Library of Congress Classification System. Review the basics of subject analysis and authority control. If cataloging is not your strong suit, consider

using flashcards or online tutorials to reinforce key concepts.

Library Management and Administration

Management topics cover a wide range of skills, including strategic planning, human resources, budgeting, facilities management, and organizational behavior. The exam may ask you to analyze a management scenario and select the best course of action. To prepare, study management principles as they apply to libraries, and

familiarize yourself with the organizational structure of California state government. Understanding how state libraries operate within the broader government framework will give you an edge.

Technology and Digital Resource S

Technology is an integral part of modern librarianship, and the exam reflects this reality. You should be comfortable with integrated library systems (ILS), discovery layers, digital repositories, and basic troubleshooting

of computer hardware and software. Questions may also cover the evaluation and implementation of new technologies. Stay current with trends such as open access, digital preservation, and the use of artificial intelligence in libraries.

Public Services and Outreach

This domain tests your ability to design and deliver programs and services that engage the community. Topics include information literacy instruction, programming for diverse populations, and marketing library services. The exam

may present scenarios involving outreach to underserved groups or collaboration with other agencies. Review case studies of successful library outreach programs in California to gain practical insights.

TEST-TAKING STRATEGIES FOR SUCCESS

Knowing the content is only part of the battle; you also need to approach the exam with a strategic mindset. Here are some test-taking tips to maximize your performance.

- **Read each question carefully.** Pay attention to keywords such as "most," "best," "first," and "not." These

words can change the meaning of a question entirely.

- **Eliminate obviously wrong answers.**

Narrowing your choices increases your odds of selecting the correct answer, even if you are unsure.

- **Manage your time wisely.**

Keep an eye on the clock and avoid spending too much time on any single question. If you are stuck, mark the question and move on, then return to it if time permits.

- **Use the process of elimination.** For multiple-choice

questions, eliminate the answers that are clearly incorrect, and then choose the best option from the remaining choices.

- **Trust your professional judgment.**

Situational judgment questions are designed to assess your practical reasoning. Draw on your education and experience, and choose the response that aligns with professional ethical standards.

- **Stay calm and focused.** Test anxiety can undermine your
