Most delivery startups opt for a Limited Liability Company (LLC) because it offers liability protection without the complexity of a corporation. Alternatively, a sole proprietorship is simpler but exposes personal assets to business risks.

Register Your Business Name

Choose a name that reflects your service and is easy to remember. Check your state's business

registry to ensure the name is available. You may also need to register a DBA (Doing Business As) if you operate under a different name.

STEP 5: ACQUIRE EQUIPMENT AND VEHICLES

Your equipment needs depend on your delivery type, but every business requires reliable transportation and basic tools.

Vehicles

You can start with your own car, rent vehicles, or lease a fleet. Consider fuel efficiency, cargo space, and maintenance costs. Many delivery entrepreneurs begin with a single used sedan or van and add vehicles as demand grows.

Delivery Gear

Even a one-person delivery service needs basic software:

- **Payment processing:** Square, Stripe, or PayPal for invoicing and online payments.
- **Communication tools:** WhatsApp Business, Slack, or simple phone headsets.
