### **ESSENTIAL PARTS OF A POLYGON**

## Vertices

Vertices (singular: vertex) are the points where two sides of a polygon meet. They are often labeled with letters such as A, B, C, and so on. The vertices are the "corners" of the polygon, and they define the shape's overall structure. In coordinate geometry, each vertex has an x,y position on the plane. The number of vertices always equals the number of sides in any polygon.

## Sides or Edges

The sides are the straight line segments that connect one vertex to the next. Each side has a finite length, and together they form the boundary of the polygon. The total length of all sides is called the perimeter. Sides are the most visible part of a polygon, and their lengths determine many of the shape's properties, such as whether it is regular or irregular.

## Interior and Exterior Angles

At each vertex, an interior angle is formed inside the polygon between two

adjacent sides. The sum of all interior angles depends entirely on the number of sides. For example, the sum of interior angles of a triangle is 180 degrees, while for a quadrilateral it is 360 degrees. Exterior angles are formed by extending one side outward and measuring the angle between that extension and the adjacent side. These angles also follow predictable patterns, which we will explore later.

## Diagonals

A diagonal is a line segment that connects two non-adjacent vertices. Diagonals exist only inside polygons with four or more sides. The number of diagonals in a polygon can be calculated using a simple formula:  $n(n-3)/2$ , where  $n$  is the number of sides. For instance, a pentagon has 5 diagonals, while a hexagon has 9.

### **CLASSIFICATION OF POLYGONS: A SYSTEM OF ORDER**

Polygons are classified in several ways, each providing a different lens for understanding **what is polygon in math**. The most common classification is by the number of sides, but other criteria such as angle measures and side lengths also matter.

## Classification by Number of Sides

This is the most straightforward way to name a polygon. Each number of sides has a specific name, many derived from Greek or Latin prefixes:

For polygons with more than 12 sides, mathematicians often use a numeric naming system such as "13-gon" or "20-gon." A polygon with 100 sides is called a hectogon, and one with 1000 sides is a chiliagon. While these extreme polygons are theoretically possible, they appear rarely outside of mathematical theory.

## Regular vs. Irregular Polygons

This classification depends on whether the sides and angles are uniform. A **regular polygon** has all sides of equal length and all interior angles of equal measure. Examples include equilateral triangles, squares, and regular hexagons. Regular polygons are highly symmetric and often appear in design and nature. An **irregular polygon** does not have equal sides or equal angles. Most polygons you encounter in everyday life are irregular. A rectangle is a common example; it has equal angles but not necessarily equal sides, making it irregular in the strict geometric sense.

## Convex vs.

## Concave Polygons

This classification is based on the measure of the interior angles. A **convex polygon** has all interior angles less than 180 degrees. Additionally, any line segment drawn inside a convex polygon will lie entirely within the polygon. Convex polygons are "bulging outward" and include shapes like squares, regular pentagons, and equilateral triangles. A **concave polygon** has at least one interior angle greater than 180 degrees. This creates an indentation or a "cave" in the shape, so that some part of the polygon appears to be pushed inward. A star-shaped polygon is a classic example of a concave polygon. Understanding whether a polygon is convex or concave is important in fields like computer graphics and collision detection.

## Simple vs. Complex Polygons

This classification deals with how the sides are arranged. A **simple polygon** has sides that do not intersect each other. The boundary forms a single closed loop without crossing. Most polygons you study in basic geometry are simple. A **complex polygon**, also called a self-intersecting polygon, has sides that cross each other. The classic example is a star polygon such as a pentagram. Complex polygons can be more challenging to analyze because their interior is not always clearly

defined. When discussing **what is polygon in math**, it is important to note that many textbooks focus exclusively on simple polygons unless otherwise stated.

### IMPORTANT FORMULAS AND PROPERTIES

---

Knowing the properties and formulas associated with polygons allows you to solve a wide range of geometric problems. Here are some of the most essential ones.

## Sum of Interior Angles

The sum of the interior angles of any polygon depends only on the number of sides. The formula is:

**Sum of interior angles =  $(n - 2) \times 180$  degrees**

where  $n$  is the number of sides. So for a pentagon (5 sides), the sum is  $(5-2) \times 180 = 540$  degrees. For a decagon (10 sides), it is  $(10-2) \times 180 = 1440$  degrees. This formula works for both convex and concave simple polygons.

## Measure of Each Interior Angle in a Regular Polygon

If the polygon is regular (all sides and angles equal), you can find the measure of each interior angle by dividing the sum by the number of sides:

**Each interior angle =  $(n - 2) \times 180 /$**

**$n$**

For an equilateral triangle ( $n=3$ ), each interior angle is 60 degrees. For a square ( $n=4$ ), each is 90 degrees. For a regular pentagon, each interior angle is 108 degrees. As the number of sides increases, the interior angles approach 180 degrees but never reach it.

## Sum of Exterior Angles

The sum of the exterior angles of any simple polygon, taken one per vertex, is always 360 degrees. This is true regardless of the number of sides or whether the polygon is regular or irregular. This property is incredibly useful for solving problems involving polygons and is a fundamental geometric fact. For a regular polygon, each exterior angle equals 360 divided by  $n$ .

## Number of Diagonals

As mentioned earlier, the number of diagonals in a polygon is given by:

**Number of diagonals =  $n(n - 3) / 2$**

So a quadrilateral has 2 diagonals, a pentagon has 5, a hexagon has 9, and an octagon has 20. This formula is derived by considering that each vertex can connect to  $n-3$  other vertices (excluding itself and its two neighbors), and then dividing by 2 to avoid counting each diagonal twice.

# Perimeter and Area

The **perimeter** of any polygon is simply the sum of the lengths of all its sides. For irregular polygons, you must add each side individually. For regular polygons, you can multiply the side length by the number of sides. The **area** of a polygon depends on its shape. For regular polygons, there is a formula involving the side length and the apothem (the distance from the center to the midpoint of a side). For irregular polygons, you may need to decompose the shape into triangles or use coordinate geometry methods such as the shoelace formula.

## SPECIAL TYPES OF POLYGONS WORTH KNOWING

## Triangles: The Simplest Polygon

For example, a square is both a rectangle and a rhombus, while a trapezoid has exactly one pair of parallel sides.
