Protect your business with comprehensive coverage: general liability, property insurance for lot and building, inventory insurance, errors and omissions liability, and workers' compensation. Dealer bonds are also required. Shop for quotes from insurers experienced with auto dealerships.

Your staff represents your brand. Key roles include salespeople, a finance and insurance (F&I) manager, a service manager/technicians, a detailer, and

Provide training on sales techniques, product knowledge, CRM software, and legal compliance (e.g., handling credit applications, test drives).
