## Traffic Control Devices and Signaling

Illinois drivers must obey all official traffic control devices, including traffic signals, signs, and pavement markings. A solid understanding of these devices is fundamental to the **Illinois Rules of the Road**.

**Traffic Signals:** In Illinois, a steady red light means a complete stop before the stop line or crosswalk. You may turn right on red after a complete stop unless a sign explicitly prohibits it. A flashing red light functions as a stop sign. A steady yellow light warns that the signal is about to turn red; you must stop if you can do so safely. Illinois law also permits left turns on red when both streets are one-way, provided you come to a complete stop first.

**Signage:** Illinois uses standard MUTCD

(Manual on Uniform Traffic Control Devices) signs. Pay special attention to regulatory signs like speed limit signs, no-passing zones, and lane-use arrows. Warning signs, such as those indicating curves, pedestrian crossings, or deer crossings, require heightened alertness. Construction zone signs carry extra legal weight; fines are doubled in active work zones when workers are present.

**Pavement Markings:** Solid white lines separate lanes of traffic moving in the same direction and should not be crossed. Broken white lines permit lane changes. Solid yellow lines separate opposing traffic; a solid yellow line on your side means no passing. Double solid yellow lines prohibit passing from either direction. White arrows guide turning movements and lane usage.

## Speed Limits and Safe Driving Practices

Speed limits in Illinois are established based on road type, traffic conditions, and engineering studies. The **Illinois Rules of the Road** specify statutory speed limits unless otherwise posted:

- Interstate highways: 70 mph (65 mph on some urban interstates)
- Other state highways and rural roads: typically 55 mph
- Urban and residential areas: 30 mph
- School zones: 20 mph when children are present and lights are flashing
- Alleys: 15 mph

However, the posted speed limit is not

always a legal entitlement to drive that speed. Illinois law requires drivers to adjust speed based on weather, visibility, traffic density, and road surface conditions. Driving at the posted limit in heavy fog, rain, or snow may still be considered reckless if conditions warrant slower speeds. Illinois also enforces a basic speed law, meaning you must never drive faster than is safe for existing conditions.

Speeding is one of the leading causes of crashes in Illinois. Beyond fines, convictions add demerit points to your driving record. Accumulating too many points can lead to license suspension and mandatory remedial driver education courses.

## Right-of-Way Rules

Right-of-way rules are among the most misunderstood aspects of the **Illinois Rules of the Road**. Importantly, no driver is ever legally granted a right-of-way; rather, right-of-way is yielded. Understanding when to yield prevents confusion and collisions.

### INTERSECTIONS AND UNCONTROLLED CROSSINGS

When two vehicles approach an intersection without traffic signals or stop signs simultaneously, the driver on the left must yield to the driver on the right. At a four-way stop, the first vehicle to arrive proceeds first. If vehicles arrive simultaneously, the vehicle on the right has priority. When making a left turn, you must yield to oncoming traffic unless you have a green arrow signal.

## PEDESTRIANS AND VULNERABLE USERS

Illinois law requires drivers to yield to pedestrians in marked and unmarked crosswalks at intersections. Drivers must also stop for blind pedestrians using a white cane or guide dog. Bicyclists and motorcyclists are entitled to the same rights and privileges as motorists. The state's "vulnerable roadway user" law imposes enhanced penalties for drivers who injure or kill pedestrians, cyclists, or highway workers due to careless or distracted driving.

## EMERGENCY VEHICLES AND SCHOOL BUSES

When an emergency vehicle approaches with flashing lights and sirens, all drivers must yield and pull over to the right edge of the roadway and stop. Move over laws require drivers to change lanes or slow down when approaching stationary emergency vehicles, tow trucks, or highway maintenance vehicles with flashing lights.

Perhaps one of the most strictly enforced rules in Illinois is stopping for school buses. When a school bus displays flashing red lights and extends its stop arm, all drivers on both sides of a two-lane road must stop. On a divided highway with a median or barrier, only traffic traveling in the same direction as the bus must stop. Violating this law carries substantial fines and potential license suspension.

## Lane Usage and

## Passing

Illinois law requires drivers to stay in the right lane on multi-lane highways unless passing or preparing to turn left. The left lane is not a "fast lane" per se, but it is intended for passing. Impeding traffic by driving slowly in the left lane is both discourteous and illegal. When passing another vehicle, you must signal your intention, return to the right lane when safely clear, and never exceed the speed limit while passing.

On roads with two-way traffic, passing is prohibited when a solid yellow line is on your side, within 100 feet of an intersection or railroad crossing, on hills or curves where visibility is limited, or when school bus warning lights are flashing.

## Seat Belts, Child Safety, and Distracted Driving

Illinois has a primary seat belt law, meaning law enforcement can stop and ticket a driver solely for not wearing a seat belt. All drivers and passengers in a vehicle must wear seat belts. Children under age 8 must be secured in an appropriate child safety seat or booster seat unless they are at least 4 feet 9 inches tall. Illinois law requires children under age 2 to be in a rear-facing car seat. Fines for child safety seat violations are steep and increase with subsequent offenses.

Distracted driving is a major focus of

Illinois traffic enforcement. Illinois law prohibits the use of handheld electronic devices while driving in most circumstances. Drivers may use hands-free technology, but texting, browsing, or using apps while behind the wheel is illegal. This is a primary offense, meaning you can be stopped solely for holding your phone. Fines for distracted driving start at \$75 for a first offense and escalate significantly for subsequent violations. If distracted driving causes a crash resulting in injury or death, criminal charges can apply.

## DUI Laws and Implied Consent

Driving under the influence (DUI) is aggressively prosecuted in Illinois. The legal blood alcohol concentration (BAC) limit is 0.08% for drivers aged 21 and over. For commercial drivers, the limit is 0.04%. Illinois has a zero-tolerance policy for drivers under 21, meaning any detectable alcohol in the system can result in a DUI conviction and license suspension.

Illinois operates under an implied consent law. By holding a valid driver's license, you have automatically consented to chemical testing (breath, blood, or urine) if lawfully arrested for DUI. Refusing a test results in an automatic driver's license suspension of 12 months for a first refusal, and up to 36 months for subsequent refusals, regardless of whether you are ultimately convicted of DUI. These consequences underscore the seriousness with which Illinois treats impaired driving.

## Vehicle Registration, Insurance, and Equipment

Beyond driving behaviors, the **Illinois Rules of the Road** include requirements for vehicle registration and insurance. All vehicles operated on public roads must be registered with the Illinois Secretary of State and display valid license plates. Illinois law mandates that drivers carry liability insurance with minimum coverage limits of \$25,000 per person for bodily injury, \$50,000 per accident for bodily injury, and \$20,000 per accident for property damage. Driving without insurance can result in fines, license suspension, and vehicle impoundment.

Vehicle equipment regulations also matter. Required equipment includes functioning headlights (used from sunset to sunrise and in adverse weather), taillights, brake lights, turn signals, windshield wipers, a horn, and mirrors. Illinois law requires a front license plate in addition to the rear plate. Window tint must comply with specific light transmission standards. Illegally modified exhaust systems or excessively loud mufflers can result in citations.

## Accident Reporting and

## Obligations

If you are involved in a crash in Illinois, state law imposes specific obligations. All crashes involving injury, death, or property damage exceeding \$1,500 must be reported to law enforcement. Drivers must stop at the scene, exchange information (name, address, driver's license number, insurance details, and vehicle registration), and render reasonable assistance to injured persons. Leaving the scene of an accident involving injury is a felony in Illinois. Even minor crashes should be documented for insurance purposes, and failure to report can lead to complications.

## Renewing Your Knowledge: Testing and Resources

The **Illinois Rules of the Road** are not static. Laws change, signs are updated, and new safety research emerges. Drivers are encouraged to periodically review the official Illinois Rules of the Road handbook, available online at the Illinois Secretary of State website. Senior
