Our mission is to make homegrown food accessible to everyone, regardless of living space. Unlike competitors, our

system is fully automated, includes a mobile app for monitoring plant health, and uses 90% less water than soil-based gardening. GreenSprout is registered as a Delaware C-Corp.

Market Analysis

The indoor gardening market has experienced rapid growth, driven by increasing consumer interest in organic food, sustainability, and self-sufficiency. Our primary target market includes urban residents aged 25 to 40 living in apartments of 800 square feet or less. Secondary markets include schools, restaurants, and corporate wellness

programs. Key competitors include AeroGarden, Click & Grow, and Rise Gardens. We will also establish partnerships with co-working spaces and apartment complexes to offer bulk discounts to residents. Our sales model is direct-to-consumer via our website, with plans to explore retail partnerships in natural grocery stores by year two.

Funding Request Projections

GreenSprout is seeking \$500,000 in seed funding. The funds will be allocated as follows: \$200,000 for final product development and tooling, \$150,000 for marketing and launch campaign, \$100,000 for initial inventory and fulfillment setup, and \$50,000 for operational expenses including legal, accounting, and software subscriptions. We offer investors a 10% equity stake with standard liquidation preferences and a pro-rata participation right in future rounds.

Financial
