These are the Cauchy-Riemann equations. When these hold, and the partial derivatives are continuous, the function is analytic. This simple pair of equations has profound implications. For instance, any analytic function is infinitely differentiable and can be represented by a power series in its region of analyticity. COMPLEX INTEGRATION: THE HEART OF THE SUBJECT

Cauchy's Integral Formula and Its Consequences

If f is analytic inside and on a simple closed contour γ , then for any point z inside γ :

$$f(z_0) = \frac{1}{2\pi i} \oint_{\gamma} f(z) / (z - z_0) dz$$

This is Cauchy's integral formula. It tells us that the value of an analytic function at any interior point is completely determined by its values on the boundary. This is a remarkable "mean value" property and implies that analytic functions are extremely rigid: if two analytic functions agree on a curve or on a set with a limit point, they are identical everywhere in their domain. This property is the foundation for many profound results, including the maximum modulus principle and Liouville's theorem (which states that a bounded entire function must be constant).

Residues and the Residue Theorem

When a function is not analytic at isolated points (called singularities), the integral around a contour enclosing those points does not vanish—and this is where the residue theorem comes in. For a function with an isolated singularity at z_0 , the residue is essentially the coefficient of the $(z - z_0)^{-1}$ term in its Laurent series expansion. The residue theorem states:

$$\oint_{\gamma} f(z) dz = 2\pi i \sum (\text{Residues of } f \text{ inside } \gamma)$$

This theorem is one of the most practical

tools in complex analysis. It allows us to compute difficult real integrals—such as those arising in Fourier analysis and probability—by converting them into contour integrals and summing residues. For example, integrals from $-\infty$ to ∞ of rational functions multiplied by trigonometric functions often succumb elegantly to this method. POWER SERIES AND THE CLASSIFICATION OF SINGULARITIES

Taylor and Laurent Series

If a function is analytic in a disk centered at z_0 , it has a Taylor series expansion: $f(z) = \sum a_n (z - z_0)^n$. When the function has a singularity at z_0 or is analytic only in an annulus, we use the Laurent series, which includes negative powers: $f(z) = \sum_{n=-\infty}^{\infty} c_n (z - z_0)^n$. Types of Isolated

Singularities

Isolated singularities come in three flavours based on the Laurent expansion:

1. **Removable singularities:** All negative coefficients are zero. The function can be redefined at the point to become analytic. Example: $\sin(z)/z$ at $z=0$.
2. **Poles:** Only finitely many negative terms are non-zero, with the most negative exponent being the order of the pole. Example: $1/z^2$ has a pole of order 2 at zero.
3. **Essential singularities:** Infinitely many negative coefficients are non-zero. The function behaves wildly near such a point; Picard's theorem says that it takes every complex value (except possibly one) infinitely often in any neighbourhood. Example: $e^{1/z}$ has an essential singularity at zero.

Knowing the type of singularity is crucial when applying the residue theorem and understanding the overall behaviour of the function.
