**Question:** When must a food handler wash their hands?

hands?

**Answer:** No. Gloves are not a substitute for handwashing. Hands must be washed before putting on gloves, and gloves must be changed whenever they become torn, contaminated, or when switching tasks such as going from handling raw meat to preparing ready-to-eat food.

### **CROSS- CONTAMINATION PREVENTION: KEY QUESTIONS AND ANSWERS**

Cross-contamination occurs when harmful bacteria or allergens are transferred from one surface or food to another. This is a major cause of foodborne illness, and the Texas Food Handlers Test places a strong emphasis on

prevention strategies.

**Question:** How should raw meat be stored in a refrigerator to prevent cross-contamination?

**Answer:** Raw meat should always be stored on the bottom shelves of a refrigerator, below ready-to-eat food. This prevents juices from dripping onto other items. Specifically, the order from top to bottom should be: ready-to-eat food, seafood, whole cuts of beef and pork, ground meat and fish, and finally, whole and ground poultry at the very bottom.

separate cutting boards, utensils, and preparation areas for allergenic ingredients such as peanuts, tree nuts, dairy, eggs, and gluten. If separate equipment is not available, all equipment must be thoroughly cleaned and sanitized between uses. Additionally, food handlers must wash their hands after handling allergens.

**Question:** Can wiping a cutting board with a damp cloth remove bacteria?

**Answer:** No. A damp cloth will not remove bacteria. Cutting boards must be washed with soap and hot water, rinsed, and then sanitized with an approved sanitizing solution. Cloths used for cleaning must be stored in a sanitizing solution between uses.

## **TIME AND TEMPERATURE CONTROL: THE MOST CRITICAL AREA**

Improper temperature control is the leading cause of foodborne illness outbreaks. The Texas Food Handlers Test includes many questions about the danger zone, cooking temperatures, and holding temperatures. Mastering these will significantly improve your score.

**Question:** What is the minimum internal cooking temperature for ground beef?

**Answer:** Ground beef must be cooked to an internal temperature of 155°F for at least 15 seconds. Because grinding distributes bacteria throughout the meat, a higher temperature is required compared to whole cuts.

**Question:** How should hot food be held for service?

**Answer:** Hot food must be held at an internal temperature of 135°F or above. Use a clean, calibrated thermometer to check the temperature at least every two hours. If the food drops below 135°F, it must be reheated to 165°F within two hours before being placed back in hot holding.

**Question:** How should cold food be held for service?

**Answer:** Cold food must be held at 41°F or below. If the temperature rises above 41°F, corrective action must be taken. Food that has been above 41°F for more than four hours must be discarded.

## COOLING AND REHEATING: COMMON TEST SCENARIOS

Cooling food safely is another area where many food handlers struggle. The test will likely include questions about proper cooling methods.

**Question:** What is the approved method for cooling hot food?

**Answer:** The two-stage cooling method is required. First, cool food from 135°F to 70°F within two hours. Then, cool it from 70°F to 41°F within four additional hours. The total cooling time should not exceed six hours. Methods to speed cooling include using shallow pans, an ice bath, stirring with ice paddles, or using a blast chiller.

**Question:** Can you cool food at room temperature on the counter?

**Answer:** No. Cooling food at room temperature is unsafe because it stays in the danger zone too long. Active cooling methods must always be used.

## CLEANING AND SANITIZING: WHAT THE TEST EXPECTS

A clean kitchen is not necessarily a safe kitchen. Sanitizing is the process that reduces pathogens to safe levels, and the test will check your understanding of the difference between cleaning and sanitizing.

**Question:** What is the difference between cleaning and sanitizing?

**Answer:** Cleaning removes visible dirt,



food particles, and grease using soap and water. Sanitizing reduces the number of microorganisms on a surface to safe levels using heat or chemicals. Both steps are necessary. A surface must be cleaned before it can be sanitized.

**Question:** What are the requirements for a chemical sanitizing solution?

**Answer:** For chlorine bleach sanitizer, the concentration must be between 50 and 100 parts per million (ppm), and the contact time must be at least seven seconds. For quaternary ammonium sanitizers, the concentration is typically around 200 to 400 ppm, with a contact time of 30 seconds. Always follow the manufacturer's

instructions and use test strips to verify concentration.

**Question:** How often should wiping cloths be stored in sanitizer?

**Answer:** Wiping cloths used for countertops and food-contact surfaces must be stored in a bucket of sanitizing solution at the correct concentration when not in use. The solution should be changed whenever it becomes dirty or at least every four hours.

## PEST CONTROL AND FACILITY MANAGEMENT QUESTIONS

Preventing pests is a shared responsibility. The Texas Food Handlers Test may include questions about how to deny pests access to the

facility and how to recognize signs of infestation.

**Question:** What is the best way to prevent pests in a food establishment?

**Answer:** The best prevention is to deny pests access by sealing cracks and gaps in walls and around pipes, installing door sweeps, keeping screens on windows, and maintaining a clean environment. Food should be stored at least six inches off the floor in sealed containers, and garbage should be removed frequently.

**Question:** A food handler spots a cockroach in the dry storage area. What should they do?

**Answer:** The food handler should notify the manager

immediately. The area should be cleaned, any contaminated food should be discarded, and a licensed pest control operator should be called. Food handlers should not apply pesticides themselves.
