UNDERSTANDING THE TEMPORARY TEXAS LICENSE PAPER ID TEMPLATE

If you have recently visited a Texas Department of Public Safety (DPS) office to renew your driver's license or obtain a new one, you likely walked out with a piece of paper that serves as a temporary placeholder until your permanent plastic card arrives in the mail. This

It is printed on standard security paper at the DPS counter and is meant to provide you with a legal form of identification while your permanent driver's license or ID card is being produced and mailed. The **temporary Texas license paper ID template** typically includes your name, date of birth, address, the document's expiration date, a

barcode, and sometimes a black-and-white photo. It is not a substitute for a plastic card in all situations, but it does carry the full legal authority of your license for a short window of time - usually 30 to 45 days, though DPS may extend this during mailing delays.

The Purpose of the Paper Interim ID

The primary reason Texas DPS issues this paper document is to bridge the gap between application and delivery. Because

Texas switched to central issuance (cards are produced at a secure facility and mailed), no DPS office stocks plastic cards on site. The paper ID serves as proof that you are legally licensed to drive or hold a state ID. It also helps law enforcement, banks, and other entities verify your identity while you wait for the hard card. The design of the **temporary Texas license paper ID template** includes security features that make it difficult to counterfeit, which is essential for preventing fraud.

HOW TO OBTAIN A TEMPORARY TEXAS LICENSE PAPER ID

You will receive a temporary Texas license paper ID

automatically when you complete one of the following transactions at a DPS office:

- **Initial license or ID application** - after passing vision, written, and driving tests (if applicable).
- **Renewal of an existing Texas driver's license or ID** - whether in person or after an online renewal that requires an in-office visit.
- **Replacement of a lost, stolen, or damaged license** - when you apply for a duplicate.
- **Address change** - if you update your address in person, the DPS

temporary paper ID reflecting the new information.

There is no additional fee for the paper ID – it is included in the cost of your transaction. The agent will hand it to you immediately after processing your application. The **temporary Texas license paper ID template** will be printed on the spot, so you do not have to wait for it to be mailed. Keep in mind that the paper ID is only valid when accompanied by your previous plastic license (if you still have it) or when presented alone if your previous license was surrendered or expired.

OFFICIAL PAPER ID TEMPLATE

To prevent fraud and identity theft, the Texas DPS incorporates several security elements into the **temporary Texas license paper ID template**. While not as robust as the plastic card, the paper ID still contains features that make forgery difficult:

- **Watermark or state seal** – Many paper IDs include a subtle image of the Texas state seal that is visible when held up to light.
- **Microtext** – Fine lines of text that are hard to reproduce with standard scanners or copiers.

- **Barcode** – A 2D barcode that encodes your name, date of birth, license number, and expiration date.

Authorized parties can scan this barcode to verify the document's authenticity.

- **Security background** – The paper may have a faint, repeating pattern (such as the word "TEXAS" or "DPS") that appears when photocopied.

- **Lamination or coating?** – Official paper IDs are not laminated, but they are printed on a durable, tear-resistant paper stock.

- **Signature** – Your signature is printed (or you sign it at the counter) directly onto the paper.

It is important to note that the **temporary Texas license paper ID template** is not the same as a "fake ID" template that might be sold online. Any attempt to create a counterfeit version using a generic template is illegal and could result in serious criminal charges.

VALIDITY DURATION AND WHERE YOU CAN USE IT

- **Voting** – Texas election law accepts certain forms of photo ID. The paper ID is considered a provisional form; you may be allowed to vote if you sign an affidavit, but it is best to bring your permanent card or a passport.
- **Employment verification (I-9)** – Employers may accept a paper ID from DPS as a List B document if it appears genuine, but many HR departments prefer the plastic card.

Because the **temporary Texas license paper ID template** is a paper document, it is more

susceptible to wear and tear. Keep it in a safe envelope or sleeve to prevent creasing or smudging.

COMMON QUESTIONS ABOUT THE TEMPORARY TEXAS LICENSE PAPER ID

Can I use it to drive immediately?

Yes. As soon as you receive it, the paper ID serves as your valid driver's license. You must carry it while driving, along with your previous expired license if applicable.

If your plastic card is delayed beyond the paper ID's expiration date, you can contact Texas DPS or visit an office to request a replacement or an extension. They may issue a new paper ID. Do not drive with an expired paper ID - doing so could result in a citation for driving

No. The **temporary Texas license paper ID template** is an official document printed by the DPS using secure software. You cannot download or edit a genuine DPS template. Any website offering a "fillable" version is likely selling a counterfeit and should be avoided.

Can I laminate my paper ID?

Lamination may interfere with the security features and barcode. DPS advises against laminating the paper ID because it can prevent verification and may void the document's validity. Keep it in a clear plastic sleeve instead.

PROTECTING YOUR TEMPORARY PAPER ID FROM FRAUD AND DAMAGE

Since your **temporary Texas license paper ID template** is your only legal identification

for up to six weeks, it is crucial to safeguard it. Here are some tips:

- **Keep it in a secure place** – Consider a wallet with a clear ID window or a dedicated folder in your vehicle.
- **Make a photocopy or take a photo** – Having a backup image can help if the paper is lost, though it will not be accepted as a legal ID.
- **Do not post pictures online** – Sharing a photo of your paper ID on social media exposes your full name, address, and driver's license number, making you vulnerable to identity theft.
- **Report loss**

THE FUTURE OF THE PAPER ID

If your paper ID is lost or stolen, visit a DPS office as soon as possible to apply for a replacement (there is a fee). You can also request a replacement online in some cases.

- **Watch for scams** – Scammers may try to sell you a “temporary Texas license paper ID template” that looks official. Only the DPS can issue a legitimate paper ID. Never pay a third party for a template or document.

THE PAPER ID: DIGITAL AND MOBILE OPTIONS

Texas is exploring digital driver’s licenses (mDL) that could eventually replace the paper interim ID. In 2024, the state launched a pilot program for a mobile driver’s license that works through a secure app. While this digital version is not yet widespread, it suggests that the **temporary Texas license paper ID template** may one day be supplemented – or replaced – by a digital equivalent. Until then, the paper ID remains a critical tool for millions of Texans.
