The South Fork

Fishing and Hunting Club

In 1879, the South Fork Fishing and Hunting Club purchased the dam and the reservoir for a mere \$2,500. The club was an exclusive retreat for some of Pittsburgh's wealthiest industrialists, including Andrew Carnegie, Henry Clay Frick, and Andrew Mellon. These men transformed the area into a summer resort complete with a clubhouse, cottages, and recreational amenities.

Critically, the club made several modifications to the dam that would prove

fatal. They lowered the dam's height by nearly 2 feet to accommodate a road across the top. They also removed the original relief pipes and discharge pipes that were designed to release excess water during heavy rains. Additionally, they installed fish screens to prevent their prized sport fish from escaping, which became clogged with debris during the storm, further impeding water flow. These modifications, driven by convenience and aesthetics rather than safety, set the stage for the disaster to come.

THE DAYS LEADING UP TO THE FLOOD

The reservoir rose at an alarming rate, and by the morning of May 31, the water level was within inches of the dam's crest. Club officials and local workers desperately tried to raise the dam's height by adding sandbags and fill dirt, but their efforts were futile. They also attempted to clear the clogged spillway, but the debris and rushing water made it nearly impossible.

THE

FAILURE OF THE DAM

The Moment of Collapse

At approximately 3:10 PM on May 31, 1889, the South Fork Dam gave way. The failure was not gradual; it was a sudden and catastrophic breach that released the entire contents of Lake Conemaugh in a matter of minutes. A wall of water, initially estimated to be between 30 and 40 feet high, surged down the narrow Conemaugh Valley, carrying with it trees, boulders, train

cars, homes, and any other debris in its path.

The flood wave moved at approximately 40 miles per hour, gaining momentum and force as it traveled downstream. It reached the small town of South Fork within minutes, then Mineral Point and East Conemaugh, and finally Johnstown itself, just 57 minutes after the dam failed.
