Accounting for Uncertain Tax Positions (UTPs)

Under ASC 740-10 (formerly FIN 48), companies must recognize the tax benefit from an uncertain tax position only if it is more-likely-than-not to be sustained upon examination by the tax authorities. This evaluation is based on the technical merits of the position and assumes that the position will be examined by the relevant taxing authority with full knowledge of all relevant information.

The process involves a two-step approach:

1. **Recognition:** Determine if the benefit meets the more-likely-than-not threshold.
2. **Measurement:** Measure the benefit as the largest amount of tax benefit that has a greater

than 50% likelihood of being realized upon settlement.

UTPs encompass a wide range of issues, from transfer pricing and research and development credits to complex international structures. The management of UTPs requires a dynamic, multi-disciplinary approach that integrates tax technical knowledge with financial reporting and legal considerations. Similarly, intercompany transactions require careful consideration. For instance, the sale of inventory from a subsidiary to a parent company may result in a gain for book purposes but is unrealized for tax purposes until the inventory is sold to a third party. This creates a temporary difference and a corresponding DTA or DTL. Special attention is required for changes in tax laws, such as the impact of the Tax Cuts and Jobs Act on the treatment of certain intercompany payments.
