# From Research to Reality

The Lominger Competency Guide did not emerge from a vacuum. It was born from rigorous, empirical research conducted by Michael Lombardo and Robert Eichinger during their tenure at the Center for Creative Leadership. Their

goal was to identify the specific behaviours and characteristics that distinguished successful leaders from those who derailed. The initial framework was published in the 1990s, and it has been refined and expanded over the years to remain relevant in a rapidly changing business environment. The word *Lominger* itself is a portmanteau of the founders' surnames, reflecting the collaborative nature of their work.

Unlike competency models that focus narrowly on job-specific technical skills, the Lominger Competency Guide emphasises transferable, behavioural competencies. # The Full Set of Competencies

The Lominger Competency Guide comprises 67 distinct competencies, organised into a clear, hierarchical structure. These competencies are not arbitrary; they are observable, measurable behaviours that can be developed over time. The full set is often referred to as the **Lominger Competency Library** or the **Lominger Competency Deck**, reflecting its origins as a physical deck of cards that

managers could use for quick reference and discussion. Each card in the deck describes a single competency, including its definition, a list of associated behaviours, and indicators of both proficiency and overuse.

## The Seven Competency Factors

To make the framework more manageable, the 67 competencies are grouped into seven overarching factors or clusters. These factors provide a high-level view of an individual's capabilities and are particularly useful for strategic

talent reviews and succession planning. The factors are:

- **Strategic & Business Acumen:** Competencies here include Strategic Agility, Business Acumen, Decision Quality, and Creativity. This factor measures a person's ability to think broadly, anticipate future trends, and make sound business decisions.
- **Leading & Managing People:** This cluster focuses on interpersonal and leadership skills. Key competencies are Building Effective Teams, Motivating Others, Developing Direct Reports, and Managing Vision and Purpose.
- **Building Relationships & Collaboration:** Competencies

such as Interpersonal Savvy, Organisational Agility, and Building Strategic Working Relationships fall under this factor. It assesses a person's ability to connect with others, influence without authority, and work across organisational boundaries.

- **Drive & Execution:** This factor includes competencies related to getting things done: Drive for Results, Action Oriented, Timely Decision Making, and Perseverance. It reflects an individual's energy, focus, and ability to overcome obstacles.
- **Personal & Interpersonal Skills:** Competencies here speak to a person's character and self-awareness. Think of Dealt with

Ambiguity, Learning on the Fly, Integrity and Trust, and Self-Knowledge. This factor is often considered the foundation of emotional intelligence.

- **Cognitive & Intellectual Skills:** This factor covers mental agility and problem-solving. Competencies include Intellectual Horsepower, Problem Solving, Time Management, and Written Communications.
- **Technical & Functional Skills:** While the Lominger model emphasises behaviour, it still recognises the importance of expertise. This factor includes functional and technical competencies such as Process Management, Managing Through

Systems, and knowledge of specific domains.

# Recruitment and Selection

One of the most common applications of the Lominger Competency Guide is in hiring. Instead of relying solely on a candidate's resume or gut instinct, hiring managers can use the competencies to structure behavioural interviews. ### Getting Started:

## Assess Your Needs

Before diving into the full 67-competency library, it is wise to define your organisation's specific objectives. Are you primarily trying to improve hiring decisions? Develop a leadership pipeline? Transform your performance management system? Your goals will determine which competencies to prioritise. Most organisations start with a core set of 8 to 12 competencies that are most critical to their strategy and culture. For example, a technology startup might prioritise "Innovation Management" and "Dealing with Ambiguity," while a manufacturing firm

might focus on "Process Management" and "Drive for Results."

## Tailoring the Framework

While the Lominger Competency Guide is designed to be universal, it is also highly adaptable. You can customise the competency definitions, add a few organisation-specific competencies, or weight certain competencies more heavily than others for particular roles. The key is to maintain the integrity of the original model while ensuring it fits your unique context. Avoid the temptation to reinvent the wheel; the power of the Lominger model lies in its research-based validity, and significant

alterations can undermine its effectiveness. Many practitioners find that using the framework "off the shelf" with minor modifications yields the best results.

## Training and Calibration

Implementing a competency model requires more than just distributing a document. Managers and HR professionals need training on how to use the competencies effectively in interviews, feedback sessions, and talent reviews. Calibration sessions are also critical to ensure consistency. In these sessions, managers discuss specific examples of employee behaviour and

align on which competency level is demonstrated. Without calibration, the same behaviour might be rated as "Developing" by one manager and "Expert" by another, defeating the purpose of standardisation. Investing in this training upfront pays enormous dividends in the quality of your talent decisions.

## Technology and Tools

Fortunately, you do not need to build everything from scratch. Many software platforms offer built-in Lominger competency libraries, including the full set of definitions, behavioural indicators, and proficiency scales. These tools can

automate the process of mapping competencies to roles, integrating with assessments, and generating reports. If you are a small or medium-sized organisation, even a simple spreadsheet or an internal wiki can work effectively as a starting point. The most important thing is to start using the framework consistently, even in a basic form, and then scale up as your comfort and experience grow.
