The SSA processes these requests quickly, and the new card typically arrives in the mail within 10 to 14 business days.

If you are not eligible to apply online, you will need to visit your local SSA office. You must complete Form SS-5 (Application for a Social Security Card) and provide original documents proving your identity, age, and citizenship or lawful immigration status. The SSA does not accept photocopies or templates—only original, government-issued documents will be accepted.

# Required Documentation for a Replacement Card

The SSA requires specific original documents to issue a replacement card. These include:

- **Proof of U.S. citizenship:** A U.S. birth certificate or U.S. passport.
- **Proof of identity:** A valid driver's license, state-issued ID, or U.S. passport.
- **For non-citizens:** Proof

of lawful immigration status and work authorization.

It is important to note that you will need to present the original documents, not copies. The SSA will verify them and return them to you. A **Print Social Security Card Template** has no place in this official process.
