WHAT IS THE HAZARDOUS MATERIALS ENDORSEMENT (HME)?

The Hazardous Materials Endorsement is a specific designation added to a Commercial Driver's License (CDL) that legally permits a driver to transport hazardous materials in quantities requiring placarding. The term "hazardous materials" (often abbreviated as Hazmat) covers a wide range of substances, from common flammable liquids like gasoline and diesel to corrosive acids, compressed gases, and radioactive materials.

The endorsement is governed by the Pipeline and Hazardous

Materials Safety Administration (PHMSA) under the Department of Transportation (DOT). To obtain this endorsement, a driver must pass a specialized knowledge test that covers topics such as material classification, packaging requirements, labeling and placarding, loading and unloading procedures, and emergency response protocols. Without this endorsement, a driver is legally prohibited from transporting loads that contain reportable quantities of hazardous materials.

The TSA will check your criminal history against a list of disqualifying offenses, which include crimes such as terrorism, espionage, treason, certain felonies, and

specific drug-related offenses. You cannot proceed with the hazmat endorsement if you have a disqualifying criminal record without having received a waiver from TSA.

Basic CDL Requirements

You must already hold or be in the process of obtaining a valid Commercial Driver's License. In most states, you cannot add the Hazmat endorsement to a learner's permit; you generally need a valid CDL first. Additionally, you must be at least 21 years old to transport hazardous materials across state lines, although

intrastate transport age limits may vary by state.
