authorized. A piece of debris, a washout, or a person near the tracks must be reported right away.

Communication and Work Zones

- **Question:** Who is responsible for establishing on-track safety for a contractor work site?

Answer

principle: A qualified BNSF employee (such as a roadway worker in charge or flagger) is responsible for establishing on-track safety. Contractors must never assume the track is protected without confirmation from BNSF.

- **Question:** What is the proper procedure when you need to enter a work zone?

Answer

principle: You must check in with the designated on-site safety coordinator or flagger. Receive a briefing on the

current track status and any hazards. Only enter after receiving verbal authorization.

Environmental and Security Protocols

BNSF is committed to environmental stewardship and security. Expect questions about:

- **Question:** How should you handle a spill of oil or other hazardous material?

Answer

principle: Immediately notify BNSF

environmental personnel and your supervisor. Do not attempt cleanup unless you have proper training and spill response equipment. Use absorbent materials to contain the spill if it is safe to do so.

- **Question:** What are the security requirements for entering a BNSF facility?

Answer

principle:

Present a valid government-issued ID, sign in at the guard shack or access point, and display your contractor badge at all times. Never share access

credentials. Report any suspicious activity.
